In 2018, Boys & Girls Clubs of Tampa Bay proudly served 22,033 youth ages 5-18 throughout Hillsborough and Pasco Counties. In serving youth, our mission is to identify those "who need us the most" and for Boys & Girls Clubs of Tampa Bay, that focus is on families and youth facing the effects of poverty. Of the youth served throughout our Clubs, 78% live at or below the federal poverty level. To best combat the affect of poverty on young individuals, Boys & Girls Clubs is dedicated to providing three pillars of development to our youth. The first pillar of Academic Success is focused around grade advancement and ultimately high school graduation. This is achieved through structured programs that enhance the child's learning environment. In 2018 the high school graduation rate among high school Seniors who regularly attended our Clubs was 98%. The second pillar of focused development is Health & Wellness. With 81% of our youth qualifying for free or reduced school lunches, See Part III, Ln 4a statement
